Current Projects

Alternative Fuel Implementation Team (AFIT) for North Carolina

This 2-year effort funded by the US Department of Energy is aimed at making it easier for fleets to use alternative fuels. Comprised of NC's Clean Cities Coalitions based in Asheville, Charlotte and the Research Triangle, and led by the NC Solar Center, this team is working with industry leaders to create an Alternative Fuel Toolkit specifically designed for fleets in the state. The toolkit will include local case-studies, resources and offer barrier reduction strategies based on feedback from over 120 project participants.



CNG Workshop Held for Fleets in City of Monroe

CCFC partnered with the Monroe-Union County Economic Development Department to present a CNG Workshop at Southern Piedmont Community College. After a general overview of the alternative fuel, coalition stakeholders including Charlotte Solid Waste Services and Frito-Lay provided and overview of



their local experiences, sharing best practices and lessons learned. The workshop concluded with a brief tour of the CNG fueling station at God Bless the USA, Inc., a private refuse hauling company based in Monroe. The station consists of two fueling posts powered by an Ingersoll Rand twin 40 horsepower compressor. Attendees were also able to watch GBUSA staff

CCFC Tapped as National Clean Cities Mentor Coalition

For a second time, CCFC has been asked to serve as a Clean Cities Mentoring Coalition within the US Department of Energy's National Program.
