


## Projects & Activities

### Autonomous & Connected Vehicles Taskforce

After successful autonomous and connected vehicle (ACV) workshops in the fall, and the subsequent ACV roadmap released in January 2018 ([viewable here](#)), Centralina COG and the Centralina Clean Fuels Coalition have since continued the conversation through the Greater Charlotte Region ACV Task Force.



Discussions have centered around a summary of the Fall 2017 workshops, goals for the task force based on the Roadmap and member perspectives, and digging deeper into cyber security and data issues tied to ACVs. Materials from these meetings are regularly updated and posted at [Centralina's ACV website](#). The consensus of the group is that Taskforce outputs and guidance should be replicable and actionable for both our region and others across the nation that are also seeking to plan ahead for ACVs in their communities.

During the most recent meeting on June 22, the 4th Task Force meeting aimed to clarify what the goals of the group were and then how best to execute them.
